#### Are non-residents allowed to purchase?

· Yes, as long as you have a 183-day work permit

# Is the purchaser required to provide a mortgage pre-approval?

 Yes, purchasers need to provide a valid satisfactory mortgage pre-approval.

# Are name changes permitted?

• Yes, within the 10-day rescission period.

## Can purchasers buy under a corporation?

• Yes, along with a personal name.
